### TENDER NOTICE

Sealed competitive tenders are invited for the supply of under mentioned items as per the specifications and terms and conditions listed below.

#### Specifications:

##### CHAIN LINK (GI)

- Mesh : 2" x 2"
- Wire Diameter : 3 mm
- Height : 4' , 5'
- Rate /Kg have to be quoted
- Length/Kg in meters have to be indicated
- Quantity required (Approx.): 4' - 400 m , 5' - 380 m

##### ANGULAR POLE (GI)

- 1.5 m length with basal crossing (35 x35 x6 mm) - 135 No. s
- 1.8 m length with basal crossing (35 x35 x6 mm) - 175 No. s

#### Terms and condition:-

- 1 Tender should be submitted in the prescribed form which can be downloaded from the web link [www.rarsptb.kau.in/tenders](http://www.rarsptb.kau.in/tenders). The cost of tender form is 0.2% of the quoted amount rounded to the nearest multiple of Rs.100/- subject to a minimum of Rs. 400/- and maximum of Rs. 1,500/- + GST 18%. The same will be accepted by way of Demand Draft drawn in favour of Associate Director of Research, Regional Agricultural Research Station, Pattambi payable at State Bank of India, Pattambi and should be sent separately along with the tender.
- 2 The tender should be accompanied by an agreement in Kerala stamp paper worth Rs. 200/- (Rupees Two Hundred only) the format of which can be downloaded from the above website. Withdrawal of tenders after its acceptance or failure to supply the items or not according to the specification will entail cancellation of tender and forfeiture of Security deposit.



- 3 EMD @ 1% of the amount offered (subject to a minimum of Rs 1,500/-) should be remitted along with the tender by a separate Demand Draft drawn in favour of Associate Director of Research, Pattambi payable at State Bank of India, Pattambi. No other Demand Draft will be entertained.
- 4 Tenderers claiming exemption from paying EMD should produce necessary evidence/ documents in support of their request
- 5 The bidder of the accepted tender should enter into an agreement with the Associate Director of Research, Regional Agricultural Research Station, Pattambi on Kerala stamp paper worth Rs 200/-. The format of the agreement is available in the web link [www.rarsptb.kau.in/tenders](http://www.rarsptb.kau.in/tenders).
- 6 The Security Deposit is 5 % of the cost of chain link and the EMD of the accepted bidders will be adjusted to Security Deposit which will be refunded after the expiry of contract.
- 7 The sealed cover containing the tender documents should be super scribed as **"Tender for Chain Link as per tender notice no. D3- 179/2021 dtd 22.02.2021"**
- 8 Tenders can be **submitted up to 2.pm on 10 .03. 2021**. Tenders received after the stipulated time will not be accepted. Tenders not furnished in the prescribed format itself will be rejected.
- 9 Tenders will be **opened at 02.30 pm** on the same day in the presence of those bidders who are present at that time.
- 10 The item should be supplied in lots as and when required.
- 11 The payment will be made through invoice/credit bill system and by NEFT only to the bank account of the supplier
- 12 Any failure on the part of supplier in the fulfillment of contractual obligations will result in the forfeiture of EMD/Security Deposit.
- 13 If any Harthal/strike / any unexpected holidays occur on the date of opening of tender, the tender will be opened at the same time on the next working day.
- 14 The decision of the undersigned in finalizing the tenders shall be final and binding.
- 15 All other technical and commercial terms and conditions as per the code rules in force in Kerala State will be applicable in this case also.



16 Tenders insisting payment in advance either full or part for releasing the documents through bank are liable for rejection.

17 Complete deduction or reduction in no. of items listed if necessary at the time of purchase order without assigning any reason will be at the discretion of the Associate Director.
